



**Digital Data Licence Agreement:
Hunter & Central Coast Regional Environmental Management Strategy (HCCREMS)
Extant Vegetation Community Map, November 2003**

In accepting the **HCCREMS Extant Vegetation Community Map November 2003** (hereinafter called "the Data") I understand that it has been supplied by the Steering Committee of the Lower Hunter & Central Coast Regional Environmental Management Strategy (hereinafter called "the Licensor")

to me _____ (hereinafter called "the Licensee") for the application to the project or uses designated below and no other purposes.

As the Licensee, I hereby agree that:

1. The Licensor grants a non-exclusive, non-transferable licence to the Licensee to use the Data for internal use only and not used for any purpose other than in direct relation to its work on the project or uses designated below. Any use of the Data beyond this designation is conditional upon the Licensee re-applying for ongoing use of the Data
2. All intellectual property rights, including copyrights for the Data are and shall remain the property of the Licensor. All hard copy products of the Data must acknowledge the copyright of the Data and the date of the data by including the notice in the form "© HCCREMS Extant Vegetation Community Map November 2003".
3. The Data provided under this licence is for the exclusive use of the Licensee. The Data may not be copied, transferred, resold, altered, decompiled, disassembled or otherwise disposed of, in whole or in part, to any other persons or organisations without the express written permission of the Licensor.
4. The data may not be reproduced or made available to third parties. The product may not be on-sold in any capacity. The Licensee shall use adequate security measures to protect the digital data from unauthorised use, reproduction, distribution or publication.
5. The Licensor makes no guarantee to provide upgrades of the Data to the Licensee.
6. The Licensee acknowledges that the Data may contain omissions and errors and that the Data is subject to change over a limited time and that changes may be impending on the date the licence is issued.
7. The Licensee must rely on its own examination, skill and expertise in determining whether the Data is accurate, suitable or safe for a particular application.
8. The Licensee acknowledges that the Data has not been developed for use on the Licensee's own software and that the Licensor makes no warranties in relation to the Licensee's software being able to utilise the Data. The Licensee must rely on its own skill and expertise in determining whether it will be able to utilise the Data.
9. The Licensee releases the Licensor from all liability, negligence, injury, death, economic loss, loss of reputation or damages incidental or consequential whatsoever arising out of the Licensee's use of the Data.

10. This licence shall be deemed to be immediately terminated if the Licensee commits, or allows to be committed any breach of the provisions of this licence. Upon termination of this licence, the Licensee shall cease using the Data, erase the Data from all forms of digital storage and return the Data to the Licensor.
